NOTE: All exhibitors must provide with entries, insurance company name, policy number, expiry date and proof of at least \$2 million liability coverage.

All trucks and trailers must enter the grounds by Gate # 6 off Huntley Road. Due to limited space on the grounds car parking will be limited to Fair Board handicap and assigned permit holders only. Vehicle and handicap parking will be available in Lion's Park parking lot by entrance off Huntley Road and in a lot at the corner of Huntley Road and Perth Street. Vehicles on the grounds without proper permits will be towed at the expense of the owner.

The sheep will be housed in the Light Horse/Sheep Barn. The showing will be inside the barn or adjacent to it.

1. Richmond Agricultural Society entry forms are preferred. Owner's name, address in full, animal name, date of birth, animal I.D. registration number (extended pedigree not required), and proof of liability insurance must be on entry form.
2. Entries cannot be changed after closing date except for substitutions approved show day with proper documentation.
3. Exhibitors will be requested, at the discretion of the Committee, to remove entries should one or more show evidence of a contagious disease or be otherwise considered unfit for show. A health certificate will not be required.
4. All animals must be registered in the exhibitor's name on or before closing date of entries.
5. Only 1 entry per class is eligible from each exhibitor, except 2 entries per class in a max. of 2 classes of the exhibitor's choice.
6. The Sheep Committee strongly recommend that exhibitors in individual classes wear black trousers and white tops.
7. A new commercial Sheep section is to encourage new exhibitors to display their commercial breeding animals. All entries in this section are in-eligible to compete in other sections. Animals must be identified and should have parentage information available. Registration certificate not applicable to this section. Same classes, rules, and prizes will be applicable to this section as all other sections.
8. Sections 31-37 have the same classes and prize money.

SECTION 37: COMMERCIAL SHEEP

1. Yearling Ewe, 3rd pair of temporary incisors must be in place, born & bred in Canada.
2. Ewe, first pair of temporary incisors must be in place, born the property of the exhibitor. **Note: A maximum of 2 purchased lambs per breed may be shown in this class.**
3. Yearling Ram, 3rd pair of temporary incisors must be in place.
4. Ram, first pair of temporary incisors must be in place, born the property of the exhibitor. **Note: A maximum of 2 purchased lambs per breed may be shown in this class.**
5. Get of Sire: born the property of the exhibitor. Three animals, first pair of temporary incisors must be in place, by the same sire. Both sexes may be represented.
6. Breeders Flock: bred & owned by exhibitor. Four animals, both sexes to be represented. Each animal in the group must have been exhibited in 1 of the preceding classes. Animals must be of 1 breed.
7. Champion & Reserve Ewe. Ribbons.
8. Champion & Reserve Ram. Ribbons.
